## SYNOPSIS OF NOVEMBER BOARD MEETING

- Approved October 7, 2020 board minutes.
- Approved October 11, 2020 2nd Annual minutes.
- Approved motion to set the 2021 POA dues at \$765 per home & \$191.25 per lot.
- Approved motion when setting the POA dues for 2021, the Board will offset the dues by \$50,000 from surplus funds and set the dues at \$745 per home and \$186.25 per lot.
- Next month - Motion to hire Jimmy Concrete to replace the wooden walking bridge at the A-Field. Money to come from Equalization Fund with total cost not to exceed \$40,000.
- Approved motion to hire ENV (Environetics) to prepare a RFB for the restoration of the Clubhouse exterior for a cost of \$18,800. This will overspend the line by \$800. Monies to come from 2021 planning budget line 507.00.
- Purchased two laptops & service plans for swim team from Costco at a cost of \$1,247.47. Money to come from line 501.02.
- Approved motion to purchase a 4HP outboard motor from Lake Hopatcong Marine at a cost of \$1,823.65 (included shipping & handling). Money to come from line 525.06
- Approved motion to allow non-members to attend Camp WML when sponsored by a WML Member/Resident family for the 2021 season. Guidelines are detailed in the attached document. Any additional cost associated with this motion would be covered by the camp registration fees.
- Did not approve motion to hold the December, January, February & March Board meetings (including closed caucuses) on zoom. No funds are necessary.
- Approved motion to accept the attached new wording of the Expenditures Policy into the Administrative Guidelines Section F.



# Athletics

**Tennis Court #4 is now available for playing both Tennis and Pickle Ball.**

## TENNIS

The Tennis Sub-Committee of the Athletics Committee wishes to thank the 308 families out of 494 who recently voted to support the rebuilding of the tennis courts. This vote total accounted for 63% of those who voted rather than the 67% required (about 17 votes shy) for the question to pass.

Encouraged by the majority of voters who favored the idea of five new tennis courts and two new pickleball courts, the Tennis Sub-Committee is working on another proposal. As we prepare the next proposal, please keep the following in mind:

### **The Rationale:**

- Four out of our existing six tennis courts are usable but deteriorating. The other two courts are unusable.
- All existing courts are end-of-life and cannot be patched or fixed anymore.
- Despite their poor condition, usage of our courts is strong and growing. With the introduction of a new facility that features five tennis courts and two pickleball courts usage will only go up.
- With a rebuilt facility we can offer the community new recreational options. For example, the WML Camp can once again offer tennis lessons and introduce pickle ball to a whole new generation.
- A new tennis facility adds to the attractiveness of our community.

### **The Research and Recommendation:**

- The Tennis Sub-Committee researched and compared three surface types and eight vendor proposals before recommending post-tensioned concrete as the best solution of our location.
- We recommended a post-tensioned concrete surface based on the outstanding 25-year warranty and amazing 60-year life-span.
- Our post-tensioned courts would cost \$450K initially but only cost \$96K over 30-years for maintenance.
- A comparable asphalt solution costs \$300K initially but costs \$360K for maintenance over 30-years.
- Asphalt is also a poor choice because with repeated freezing and thawing it requires frequent fixing of structural cracks – think about our asphalt roads and driveways every spring!

### **The Finances:**

- Funds are available in the WML Capital Improvement (\$200K) and WML Sinking Fund (\$300K) for this project.
- If we spend these funds on the tennis courts, WML still has more than sufficient funds for any emergencies.
- This investment in our community will not directly raise dues.
