SECOND ANNUAL MEETING SUNDAY, OCTOBER 19

Come out to vote! Majority rules!

Do not let a small percentage of members decide your dues.

Elections for Officers, Board Of Director seats, and the Sinking Fund ballot question will take place between 9:00 am and 4:00 pm.

Budget line voting begins at noon as long as a quorum of 50 people are present.

Pages 7, 8 & 9 of this newsletter have information about the candidates who are running, absentee ballot procedures, and the Sinking Fund ballot question.

YOUR BUDGET, YOUR DUES

The results show a decrease of \$73,304 in the 2015 preliminary budget. The proposed 2015 budget totals \$1,524,306. The projected dues for 2015 will be approximately \$639 based on no additional changes to this proposed budget. The outcome of the vote at the 2nd Annual Meeting could change these projected dues. The POA budget will be voted on line by line on Sunday, October 19 at the 2nd Annual Meeting starting at noon. A quorum of at least 50 members is required to begin voting.

MEET THE CANDIDATES!

White Meadow Lake is having a Candidates night just before the start of the October 15 Board meeting. Each candidate will have 5 minutes to speak about themselves.

ELECTION PROCEDURES

The Board of Directors in July 2010 approved the following procedures for the Annual Elections.

1. An Election Committee shall be established as provided for in Section 36 of the Constitution. The President, with the approval of the Board, shall appoint the members. This Committee shall consist of three members and one alternate. The members shall be Board members not currently running for office. If there are not enough Board members meeting these criteria, then the President with the approval of the Board will select non-board members in good standing having no affiliation to any of the candidates to the election or to other Election Committee Members to fill the Committee. The Election Committee shall be appointed after the Nominating Committee has announced its selections.
2. The election will start at 9:00 am and end at 4:00 pm or as otherwise announced at a Board meeting.
3. The Election Committee will administer the election based upon the rules and procedures that have been developed and must be on the premises throughout the duration of the election. The Committee may make such rules and procedures provided they are not inconsistent with these procedures or the Constitution with the goal of making the election fair and objective.
4. Members of the Election Committee are to be familiar with the sections 26 and section 36 of the Constitution.
5. There are to be no signs or other campaign literature on POA property. The Committee may take such steps as they deem necessary in this regard.
6. On Election Day, candidates may not campaign on POA property or within 200 feet of the Club House. The Committee may take such steps as they deem necessary in this regard.
7. The order in which candidates appear on the ballot shall be by random draw conducted by the Election Committee. The ballot shall designate only the candidates name and shall not show any affiliation with any other candidates. However, those candidates selected by the Nominating Committee may be so noted.
8. At least one and preferably two members of the election committee shall be in control of the ballot box at all times.

BOAT REMOVAL DATE

Sunday, October 19

Boats must be removed from POA property no later than October 19, 2014 or you will incur a \$50 fine. If not removed by December 14, 2014 you will incur a \$100 fine and it will be towed at the owner's expense.

WINTER BOAT STORAGE

All POA members in good standing are now given the opportunity to keep their boats in the Beach 2 parking lot over the winter. Certain rules and restrictions apply:

1. Current dues, past dues, and penalties must be paid in full.
2. Applicants must apply at the Clubhouse office where slots will be allocated by lottery.
3. Stickers must be visible at all times.
4. The boat must be on a trailer that is properly registered.
5. There will be a \$250 yearly assessment fee plus a \$100 security deposit that will be refunded if the boat is removed from the parking lot by May 14, 2015 (or when the POA docks are available if sooner than May 14, 2015).
6. The boat owner must sign a waiver absolving the POA of any liabilities. Liability document to be created by the White Meadow Lake attorney.
7. This will be done on a first come first serve basis.
8. Boats will be parked on the beach side of parking lot at Beach 2.

The smallmouth bass has, “a mouth not reaching beyond the rear margin of the eye, 9 to 16 vertical bars along the side, poorly separated dorsal fins, smaller cheek scales, and a sleek dorsal profile between the snout and first dorsal fin.”

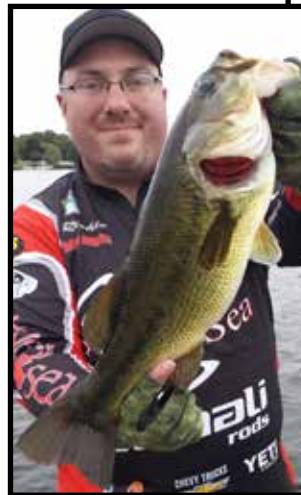

By now the fall Bass bite is underway! I have been having success fishing swimbaits in and around the weedlines. I am rigging my swimbait on a Lazer TroKar Weighted Magnum Swimbait Hook size 7/0 or for a

finesse bite a 1/8 ounce jig. Bass are feeding up on bait fish and what better way to catch them than mimic what they are eating!

Spinnerbaits are also great baits to move fast and cover water and find active fish! I like to fish the Bling Spinnerbait from River2Sea and make clockwise casts and keep moving along! You will pick up big Bass fishing Spinnerbaits in the fall!

REPORT ON 1ST ANNUAL MEETING

On Wednesday, September 17 the 1st Annual Meeting of the WML Property Owners Association was held as mandated in Section 17 of the Constitution & By-Laws. A report from the Nominating Committee was read listing the qualified candidates for Officer and Board of Director positions. Nominations from the floor were accepted by the people who were nominated. ABSENTEE BALLOTS

You may request an Absentee Ballot Packet in person at the POA office until Thursday, October 16 by 4:30 pm. For your vote to count, all Absentee Ballots must be returned to the POA office no later than Saturday, October 18 at 1:00 pm.

ABSENTEE BALLOT PROCEDURE:

An absentee ballot packet may be requested in person at the office or by mailing in the request form for an absentee ballot.

The absentee ballot packet will consist of the ballot, a white envelope and a brown envelope. The ballot will be placed in the white envelope, which will be placed in the brown envelope. The outside of the brown envelope must have the voter's name and address as well as the signature, printed name and address of the bearer of the ballot whether it is mailed in or hand carried. Each person may hand carry only one ballot and must sign the logbook when the ballot is delivered.

Each absentee ballot that goes out will be numbered and embossed with the White Meadow Lake seal.

When the ballot is returned, it will be date stamped, recorded in a logbook, and placed in a lock box that will not be opened until the day of the election. The only three keys for the lock box will be possessed by a non-running Board member selected by the Election Committee, the Office Manager and the Chairperson of the Election Committee. When the absentee ballot comes in, the voting card for that person will be pulled to prevent them from voting on the day of the election. Absentee ballots will be accepted until 1:00 pm the day before the election.

On Election Day, the absentee ballots will be counted by the Election Committee starting at 3 pm. Following County election procedure, challengers may be present at the counting of the absentee ballot votes. However, a candidate can be present after having received permission from the Election Committee. The Election Committee has the discretion to start counting the absentee ballots earlier, if there is a large number of returns.

THE SINKING FUND & CAPITAL IMPROVEMENT FUND

The Sinking and Capital Improvements Funds were created as a way for the POA to accumulate funds for large projects. By using money from these funds for large capital projects and not having to expense large ticket projects to any one year's operating budgets, our dues are not affected by the approval of spending from these funds. For that reason, the phrase "approval of this will not increase your dues" is stated on the Ballot Questions. The only way we are able to increase these two funds is from budget surplus and extraordinary other income such as collections of dues in arrears, increased volume of initiation fees collected and other miscellaneous income.

THE SINKING FUND (Section 33)

There shall be created a Sinking Fund. The Board of Directors are empowered to appropriate to such Sinking Fund up to eight (8)% of the current year's budget in the event of any surplus or unexpended funds. The account may also be funded from the annual budget at the amount not to exceed three (3)% of the current years budget. Regardless of the amount allocated in the budget line item, the total amount appropriated to the fund cannot exceed the eight (8)% cap. Money to the Sinking fund shall be invested in United States Government Securities or IN SUCH TYPES OF SAVINGS THAT ARE INSURED BY THE UNITED STATES GOVERNMENT, and no money shall be used or withdrawn from said Sinking Fund, except by a two-thirds (2/3) vote of the membership voting on said question. Any surplus in the current year's budget not appropriated to the Sinking Fund shall be included in the following year's budget, as part of anticipated revenues. The general treasury of the Association shall consist of all funds now belonging to the Association or that may become due and owing the Association. Any income derived from the Sinking Fund shall be added to the Sinking Fund.

PROCEDURES FOR CHALLENGERS:

1. A Challenger cannot be a candidate.
2. Anyone wishing to be a Challenger must submit their name to the Election Committee in writing seven (7) days, prior to the election, to get "credentialed", that is, their name will be recorded as well as the candidate and/or Question they are representing. If the Challenger is representing a Question, a maximum of two (2) Challengers per Question will be allowed, one representing the "Yes" Answer and the other representing the "No" Answer. Challengers must be POA members in good standing.
3. Each candidate is entitled to one Challenger.
4. Challengers will sit at long tables behind the Election Board workers and will follow the rules of a county/town election. That is, they are not to interfere with a voter in any way. Any questions must be directed to an Election Board worker, i.e. if they did not hear a voter's name.


