SYNOPSIS OF JANUARY BOARD MEETING

- Approved motion to enter into a contract with Nisivoccia LLP, to provide Country Club financial auditing services & tax preparation for the 2020 fiscal year as described in their engagement letter, for an amount up to \$17,600. This includes the price quote of \$16,000 & a contingency amount of \$1,600 (10%) for potential additional work & fees. Monies to come from Country Club.
- Approved motion to enter into a contract with Nisivoccia LLP, to provide POA financial auditing & tax preparation services for the 2020 fiscal year as described in their engagement letter, for an amount up to \$23,925. This includes the price quote of \$21,750 & a contingency amount of \$2,175 (10%) for potential additional work & fees. Monies to come from line 513.03. This will overspend the line.
- Approved application for Household Membership.
- Approved motion to accept salaries as discussed in closed caucus.
- Approved motion to move a minimum of \$10,000 per month from the POA Country Club Reserve Fund line 542.04 to the Country Club Reserve Fund account beginning in March 2021. This monthly amount may be increased, up to the POA budgeted amount, upon approval of the Treasurer & President.
- Defeated motion to revise Section S, Election Committee, #10 & add #11 to the Administrative Guidelines to reflect what complies with the NJ regulation & what was added by the Legal & By-Laws Committee.
- Approved motion to hire Travis Hubert as Day Camp Director for WML Camp 2021 season.
- Approved motion to hire Meghan Mattison as Day Camp Assistant Director for WML Camp 2021 season.
- Approved motion to adopt camp budget & rates for the 2021 season.
- Entered a one year service & maintenance agreement with NJ Mechanical, LLC for our appliances/equipment at a cost of \$1,279.50 Money to come from Country Club.
- Approved motion to expend \$1,620.70 with POS Solutions for the annual support and maintenance contract for the POS system. Funds to come from Country Club.
- Approved motion to offer Waterfront Manager position to Brian Boardman for the 2021 season; in accordance with discussion from closed caucus.
- Hired B.A. Colella Heating & Cooling LLC for an emergency repair to a pipe in the clubhouse that began to leak after the circulator pump was repaired at a cost of \$2,288.71. Money to come from line 517.04.
- Withdrew motion to re-affirm the Administrative Guidelines changes made to Section S, Election Committee, Numbers 1,2,3 & 10 on July 15, 2020.
- Approved motion to revise Section S, Election Committee, #10 & add #11 to the Administrative Guidelines to reflect what complies with the NJ regulation & what was added by the Legal & By-Laws Committee.
- Approved motion to purchase trout from Musky Trout Hatcheries LLC for fish stocking of our lake at a cost of \$3,151.84. Funds from line 521.03.
- Approved motion to spend up to \$2,300 for materials to have maintenance build kayak racks. Funds from line 505.01.
- Approved motion to purchase two new dock sections from Custom Docks, spend up to \$9,525, including tax. Funding to come from line 505.01.

All motor boats must be registered with the state of New Jersey or possibly another state if it shows the WML homeowners name, but current registrations must be provided to receive a boat tag, this includes lakefront homeowners. Our boat patrol will be monitoring the lake to make sure all rules are being followed. The Security and Lake committees and Board of Directors appreciate everyone's cooperation with this. Any monetary fine must be paid prior to being considered in good standing. Boat sign up days will take place in the ballroom with lines forming on the deck. All dues must be paid in full, and masks must be worn inside the building.

The ballroom and Gold Bar are open on weekends. Stop in with some takeout or delivery and have dinner and a drink Friday and Saturday nights.

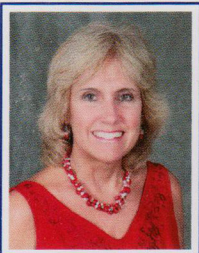

TENNIS & PICKLEBALL COURTS

The Tennis Sub-Committee of the Athletics Committee is discussing ways we might help secure construction of new WML tennis and pickleball courts. As many of you know, the current six tennis courts are in poor repair. Two of the six courts cannot be used at all. One of the four useable courts doubles as a near-standard pickleball court. The useable courts have significant cracks and low spots where water accumulates causing further damage. That said, the courts are still used for tennis and pickleball most of the year, including in January 2021. Court usage remains high although the court quality is low and deteriorating quickly in several areas. Please go and take a look if you can. To build community support for the project, the Tennis Sub-committee will 1) write articles for the WML newsletter & 2) conduct Zoom sessions describing topics related to the tennis courts. The first information session will be Thursday, February 25 at 7:30 pm. The topic is "Our Story So Far and Surface Comparisons", link is below. We look forward to your input.

Background, Recapping:

The solution proposed and narrowly defeated last October, is summarized as follows:

- Five new tennis and two new pickleball courts constructed over the current tennis courts.
- Courts constructed using the post-tensioned concrete method.
- Funds were available and the cost would not directly raise dues.
- The cost was \$451K, or about \$200.00/household. We believed the \$200 dollar value will be returned in the 30+ year life of the new courts, many times over.

Why Post-Tensioned Concrete?

- The post-tensioned method uses tensioned cables to compress the concrete, preventing nearly all cracks. If there are cracks, they won't grow in the compressed concrete.
- Extremely durable and long-lasting with excellent planarity and less waviness.
- 25-year warranty against structural cracking and 60+ years life expectancy.
- Surface is maintenance-free except for painting every 5-7 years.
- More hours of tennis play due to effect of excellent planarity on drying time.
- Lower life-time cost and lower maintenance cost versus a similar asphalt surface.

BOAT REGISTRATION ALL DUES MUST BE PAID IN FULL.

Residents can register for only 1 (ONE) boat space during the first 3 weeks of registration.
(1 Dock OR 1 Rack OR 1 Steel Bar OR 1 Trailer Space)

**NO OUTSIDE LIST WILL BE HONORED!
NO EXCEPTIONS!**

Saturday, March 13**

May be done after April 7 during regular office hours.

BOATING RULES & REGULATIONS* All DUES & FINES must be paid in full to obtain a White Meadow Lake 2021 Boat Tag.

- NJ DMV BOAT REGISTRATION & BOAT SAFETY CERTIFICATE are required for GAS & ELECTRIC powered boats to apply for a boat tag.
- BOAT, TRAILER & MOTOR SIZE- Boat & Trailer Length & Width are required. Maximum boat length-16 ft. Maximum Horse Power- 9.9 HP
- ONLY 2 BOATS PER RACK are allowed.
- OCCUPY DATE- Assigned space(s) must be occupied on May 10, for both dock and land.
- Spaces not occupied on May 10 may be reassigned upon a resident's request for the vacant space. The Office will contact the vacant space holder to advise them reassignment will be done, if after one week the space is not occupied. Extenuating circumstances will be considered.
- NO Waiting List will be maintained.
- Residents may SWAP SPACES after notifying the office and obtaining a replacement boat tag for the new space assigned.
- BOAT TAGS must be displayed or POA Security will padlock the boat until the proper tag is visible.
- HANDICAP accessible boat spaces will be available at all locations. A NJ state issued Handicap ID is required.
- CLEAN both your boat and trailer after it has been in another body of water before putting it back into WML.
- REMOVAL DATES- All Boats & trailers must be removed from WML property before November 9 or the resident will incur a \$100 fine per boat, in addition to a \$10 penalty per boat/per day.

COMPLIANCE WITH LOCAL & STATE RULES & REGULATIONS: Initial

- I agree to comply with all applicable laws, rules & regulations, including those restricting overall boat length to 16 ft. and motor to 9.9 horsepower.
- I agree to abide by all rules of the road including lighting after dark, speed and absence of wakes.
- NJ State rules require boat operators to carry a current boat operator's license while operating power vessels.

COMPLIANCE WITH POA RULES & REGULATIONS: Initial

- I agree that WML POA is not responsible for damage to any boats or trailers left on POA property.
- I agree to display the WML POA ID tag on the right rear quarter of the boat.
- I agree to store my boat in my assigned space number and in a manner to ensure no damage from my boat to POA docks and racks.
- I agree that if my boat(s) IS NOT in the assigned space (Dock or Rack) ON May 10, 2021, my space may be reassigned if the POA Office has not been notified in advance.
- I agree to notify the WML POA Office if my boat will be off POA property for a period longer than 7 days.
- I agree to remove all my boat(s) and trailer from POA property no later than November 8, 2021.
- I agree that if my boat(s) or trailer is NOT removed by these dates, I will incur a \$100 fine per boat and a \$10 penalty per boat/per day. All boats and trailers on POA docks or land spaces shall have locks cut and be impounded and stored at my expense.
- I agree that failure to comply with these Rules and Regulations may result in loss of my boating privileges on White Meadow Lake.

BEACH 1 FESTIVAL DAY KAYAK REMOVAL: Initial

- Must be removed by July 15th and can be returned by July 19th. If a rain date is needed for fireworks, you will be notified to remove your boat for that day.

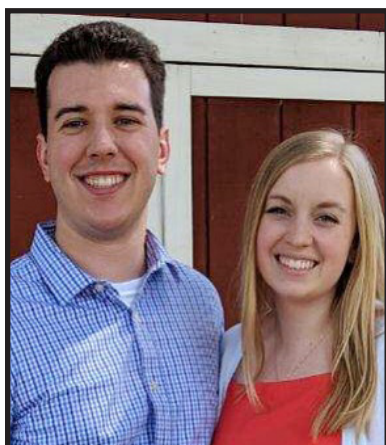



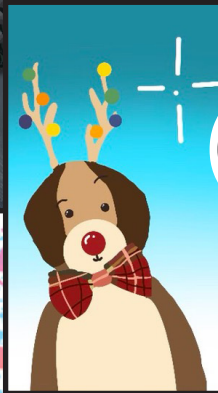
